

# CITY OF ST. REGIS PARK NEWSLETTER June 2016



Dear Fellow Residents:

I want to make you aware of several developments affecting you and our City. At the May Council Meeting, the City's annual budget for the 2016 – 2017 fiscal year beginning July 1 was tentatively approved providing the same services to residents at no increase in costs. Most St. Regis Park residents recently received a notice of real estate assessment from the Jefferson County Property Valuation Administrator (PVA). State law requires all property be assessed at fair market value as of January 1st. However, there was no increase in the St. Regis Park tax rate this past year, and I am pleased to report the tax rate for the coming fiscal year will actually be reduced, with no increase in the sanitation tax.

The current Ad Valorem (property tax) rate for the City of St. Regis Park is \$0.138 per one hundred dollars of the assessed value set by the Jefferson County PVA. The upcoming tax rate will be \$0.118. In addition, the City's Sanitation Tax will remain the same -- \$173.05 per household. Again, the City Council has continued to demonstrate their commitment to fiscal responsibility.

2016 will be a significant and important year for not only the City of St. Regis Park but the nation as a whole. This year's General Election is scheduled for Tuesday, November 8. It is a Presidential Election for our country, a Senatorial election for Kentucky, and a nonpartisan election for our City. All seven (7) City Council seats are up for election this year. Council Members are elected every two (2) years. Candidates must be at least twenty-one (21) years of age, a resident of the City of St. Regis Park for not less than one (1) year, a qualified voter in the City, and he/she must reside in St. Regis Park throughout his/her term of office.

For information on candidate filing procedures, qualifications for each office, filing fees and sample filing forms, you may download the *"Declaring Your Candidacy"* publication at www. sos.ky.gov/elections or call 502/574-5886. I encourage all qualified residents to consider becoming active in your City's government, and run for public office.

As always, if you have any questions, comments, or concerns, the Council and I want to hear from you. After all, the City of St. Regis Park is a great place to live and together, we can make it even better!

#### PUBLIC HEARING NOTICE

The City Council of the City of St. Regis Park will hold a public hearing (as required under Kentucky Revised statutes) to collect public comments and testimony for and against an ordinance setting its tax rate on real property for the upcoming year; as well as setting the Road Fund budget for the upcoming year. The public hearing will be held on Tuesday, June 7th, 2016, at the hour of 7:00 p.m. at the McMahan Fire Station, McMahan Fire Department, 4318 Taylorsville Road, Louisville. The public is encouraged to attend. As required by state law, this notice includes the following information:

- (1) The 2015 tax rate was \$.138 per \$100 of assessed valuation and produced \$148,527.25 in revenue; the compensating tax rate (the rate that would produce the same revenue as 2015) is \$.114 per \$100 of assessed valuation.
- (2) The 2016 proposed tax rate is \$.118 per \$100 assessed valuation and is expected to produce \$153,532.82 in revenue.

St. Regis Park proposes to exceed the compensating tax rate of \$.114 per \$100.00 of assessed valuation; with the expected revenue to be spent in the areas of general government expenses.

## CITY OF ST. REGIS PARK MINUTES OF THE REGULAR MONTHLY COUNCIL MEETING May 3, 2016

Following are the Minutes of the regular monthly Council Meeting for the City of St. Regis Park, held at 7:00 p.m., Tuesday, May 3, 2016 at 4318 Taylorsville Road, Louisville, Kentucky 40220.

## ROLL CALL:

Present: Mayor Brandt Davis; Council Members Bob Graves, Stephen Hoard, Louie Schweickhardt, Eric Shackelford, Frank Wheatley, Cheryl Willett Absent: Council Member Talbott Allen.

**MAYOR'S REPORT** 

Mayor Davis introduced Tony Lindauer, Jefferson County Property Valuation Administrator and Ms. Colleen Younger, Jefferson Count Property Valuation Chief of Staff. Mr. Lindauer and Ms. Younger explained the process for valuing homes in the City of St. Regis Park and the process to appeal valuations. ## FINANCIAL REPORT:

Mr. Charlie Veeneman, City Accountant, presented the Financial Report for April 2016. General Fund revenues for the month were \$6,017.20 with year-to-date revenues at \$354,524.78. Total expenses for the month were \$18,628.60 with year-to-date expenses at \$245,274.33 resulting in year-to-date revenues over expenses of \$109,250.45.

Road Fund revenues for the month were \$2,360.74 with year-todate revenues at \$24,193.95. Total expenses were \$0 with yearto-date expenses at \$11,980.00, resulting in year-to-date excess revenues of \$12,213.95.

Ms. Willett made a motion to approve the April 2016 Financial Report. The motion was seconded by Mr. Shackelford, and it passed without dissent.

## **MINUTES:**

Ms. Willett made a motion to approve the Minutes of the Regular Council Meeting held on April 5, 2016. The motion was seconded by Mr. Shackelford, and it passed without dissent.

## TREE BOARD:

Ms. Jane Ecker of the Tree Board, along with City Arborist, Ms. Cindi Sullivan, attended the meeting and discussed the following:

- The City will plant 28 trees prior to the end of this fiscal year.
- A draft copy of the Tree Maintenance Contract was submitted for review and approval.
- A tree photo contest will be held in the upcoming months.
- Tree City USA signs will be mounted and the City may purchase additional signs in the future.

# Arbor Day, 2016 St. Regis Park is a Tree City USA

The City's second annual Arbor Day celebration on April 23rd was one not to be missed—so if you did, be sure to come next year! The highlight, of course, was the awarding by Sarah Gracey of the State Forestry Service, on behalf of the Arbor Day Foundation, the designation of Tree City USA to the City of St. Regis Park, Kentucky. We join more than 3400 other communities throughout the country that have earned the honor through a commitment to restore and maintain a tree canopy. Council members Bob Graves and Cheryl Willett, and Tree Board members Jane Ecker, Joe Hinkle, and Mary Mattingly accepted the award on behalf of the City. selected them based on the variety and quality of trees in their yard, is woven into the history of St. Regis Park. Dorney's parents, Ken and Phyllis Thompson, bought their home in 1953 and began to plant trees. When St. Regis Park was incorporated a little later, Ken was named the first mayor, and St. Regis Park's charter was signed under the shade of one of the side-yard trees! In the front and side yards of the home are three dogwoods, a Japanese maple, a crabapple, a redbud, a silver maple, a Shingle oak, a Golden rain tree, a crape myrtle, a ginko, a honey locust, a Saucer Magnolia and a Spruce! When the first-generation Thompsons moved, the next generation moved in, and


# **BRANCHING OUT**



## OUCH!

Often our precious trees get "nicked" and damaged when we mow the grass. You can avoid this tree pain

with a generous band of mulch around the tree base. When you signed the maintenance agreement for your tree you agreed to maintain a healthy 2-3 inch layer of mulch over the root zone and keep the mulch from touching the trunk of the tree. When you apply the mulch, be sure to spread the mulch with a "flare" or depression around the tree. Piling the mulch into a "volcano" style can



suffocate tree roots and kill a tree, deflect moisture and make the tree susceptible to disease. See illustration below:

## Tree Maintenance Reimbursement Starts July 1

Here's how it will work:

 Grants are for owners of homes in St. Regis Park.
There is a limited pool of funds allocated to this project; as well as a maximum limit for each grant.

 A homeowner may receive up

to

40% of the cost of tree maintenance or removal not to exceed \$500. Grants will be reviewed and awarded by the Tree Board and city arborist, based on their determination as to the most effective use of the funds to increase and maintain the tree canopy in the City of St. Regis Park.

• A homeowner may request to participate in the grant program by emailing name, address, email address and phone number to msmattingly@outlook.com and briefly describing the tree location and work he/ she believes needs to be done. Only trees in front or corner side yards are eligible for maintenance work.

> The arborist will visit the site and advise and approve work
> to be done. If there are questions the homeowner may contact the arborist for discussion at cindihsullivan@ gmail.com.

• The arborist will give the homeowner a copy of an agreement form with a description of the approved work to be done which will be signed by both the arborist and the homeowner. The original copy will be given to the City Treasurer.

- Upon approval, the homeowner will contact a tree contractor individually. Work must be performed by a qualified, insured, and bonded tree contractor, with a certified arborist on staff. The City will not be a party to the contract.
- The work must be completed by April 15, 2017. Once the work is completed, the homeowner notifies the arborist by emailing Cindihsullivan@gmail.com. The arborist will visit the site and verify the agreed upon work has been done by an approved contractor by again signing the homeowner's copy of the agreement form.
- The homeowner will mail the copy of the agreement form with both signatures accompanied by a copy of the contractor's bill, describing the work done, to the City Treasurer, P.O. Box 20429 40250-0429
- The City Treasurer will calculate 40% of cost of approved work, not to exceed \$500, and issue a check to the homeowner.
- No homeowner delinquent in taxes will be eligible for reimbursement.

# INFORMATION TO IMPROVE HOMEOWNERSHIP YOUR HOME MAY BE WORTH A LOT MORE THAN YOU THINK



Real estate lost a lot of value during the recent recession but most areas have rebounded considerably. Homes are worth more now than they were before the housing bubble burst. In fact, Greater Louisville is the second highest housing

market in the country only behind New Orleans.

The dynamics are classic for this type of market: inventories are low, mortgage rates are low and demand is high. All price ranges are on the rise with some at an even higher rate because the short supply is causing competition among buyers.

Another reason many homeowners may have more equity is simply not staying current with what is going on in the market. In a recent FNMA study, it indicates that 23% of owners believe they have negative equity in their home when actually it is 9%. 37% believe they have greater than 20% equity in their home when actually 69% of homeowners do. Even if you're not planning to sell your home, knowing the value helps you understand your financial position better. The interest on home equity debt up to a \$100,000 limit is tax deductible and can be used for any purpose. Owner's commonly refinance to eliminate mortgage insurance, consolidate mortgages, pay off higher interest rate debt like credit cards or student loans or to buy out an ex-spouse's equity.

Be aware that an automated value model like Zillow Zestimates uses algorithms to determine a price and while it may be in the ballpark, AVM results may only be accurate about 20% of the time. A comparable marketing analysis or broker's price opinion will be more accurate due to the subjective approach that will be used by an agent with personal experience in the area. An agent will consider factors like condition, floor plan, marketability and demand.

# PUBLIC SAFETY CORNER CLEAN YOUR YARD TO FIGHT ZIKA Mosquito-proofing can prevent outbreaks

Although the Zika epidemic has been declared an international health emergency, fighting the mosquitoes that spread it could be a profoundly local battle. In fact, Ground Zero could be your own back yard.

Homeowners are being called on this summer to help control mosquitoes by cleaning up trash and other manmade containers that can collect standing water where insects breed. Mosquito-proofing your yard may be seen as a civic duty.

While tipping over bird baths once a week may not be seen as heroic work, such simple maintenance may help prevent mosquitoes from infecting pregnant women. Homeowners are in a perfect position to control the species which prefers to live inside homes. These mosquitoes rest under beds, inside closets or beneath patio furniture. They may fly only a few feet in their lifetime, emerging from their hiding place only to nip its victim on the legs, then quickly fluttering back to safety.

Although Zika has not yet spread among local mosquitoes in the continental United States, that could change this summer if native mosquitoes bite travelers who return with the virus in their blood. The Center for Disease Control (CDC) advises Zika is already spreading among homegrown mosquitoes in Puerto Rico. These mosquitoes are tough to control. Females need only a teaspoon of water in which to lay eggs in almost anything – a bottle cap, a candy wrapper, the folds of a plastic tarp, discarded tires, children's toys, the seat of a lawnmower. Do your part. Walk around your yard at least once a week to see if you have any containers of standing water which might be a breeding ground. These simple acts could possibly



reduce the spread of this deadly virus.
