There are nearly 40,000 *Little Free Library* book exchanges around the world, bringing curbside literacy home and sharing millions of books annually. ## MINUTES OF THE REGULAR MONTHLY COUNCIL MEETING

November 1, 2016

Following are the Minutes of the regular monthly Council Meeting for the City of St. Regis Park, held at 7:00 p.m., Tuesday, November 1, 2016 at 4318 Taylorsville Road, Louisville, Kentucky 40220.

### **ROLL CALL**:

Present: Mayor Brandt Davis; Council Members: Talbott Allen, Bob Graves, Stephen Hoard, Eric Shackelford, Louie Schweickhardt, Frank Wheatley, and Cheryl Willett.

### **MAYOR'S REPORT**

Mayor Davis introduced Jeff O'Brien, AICP, Deputy Director of the Office of Advanced Planning for Louisville Metro. Mr. O'Brien explained the agency's mission is to provide for economic and community development. The project combines business attraction, expansion and retention activities, as well as talent and workforce attraction, with all of the city's real estate development, land use, planning and design functions to present a unified solution for job growth and quality of place. There will be several work group sessions. Mr. O'Brien encouraged local leaders to attend. More information can be found at https://louisvilleky.gov/government/louisville-forward.

Mayor Davis introduced Ms. Sarah Provancher, a candidate for Kentucky State Representative, District 31. Ms. Provancher discussed her qualifications and intentions for seeking election on November 8, 2016.

Mr. John Mc'Intyre, CPA with Mc`Intyre and Wooldridge, PSC, delivered the independent 2015-2016 Financial Audit report. Mr. Graves made a motion to accept the audit report, as presented. Mr. Shackelford seconded the motion, and it passed without dissent. There were no significant findings. The required information will be published in the December 2016 newsletter.

Mayor Davis recommended the City provide funding for the purchase and installation of a Little Free Library book box. The Little Free Library is a nonprofit organization that sets out to encourage people to "take a book, return a book." It encompasses three main ideas: a sense of community, reading and providing books for children, and promoting literacy for adults and children and libraries around the world. Ms. Jaclyn Mullin, a resident of St. Regis Park, will coordinate the purchase and installation of the box. Ms. Mullin has received permission to install the box at the Church of the Ascension. The estimated cost is \$300.00. Council members had no objections to the funding.

### **FINANCIAL REPORT:**

Mr. Charles J. Veeneman, City Accountant, presented the Financial Report for October 2016. General Fund revenues for the month were \$27,698.64 with year-to-date revenues at \$283,923.13. Total expenses for the month were \$21,478.87 with year-to-date expenses at \$109,481.31 resulting in year-to-date revenues over expenses of \$174,441.82.

Road Fund revenues for the month were \$2,724.31 with year-to-date revenues at \$10,307.25. Total expenses were \$0 with year-to-date expenses at \$0, resulting in year-to-date excess revenues of \$10,307.25.

Mr. Shackelford made a motion to approve the October 2016 Financial Report. The motion was seconded by Ms. Willett. It passed without dissent.

Mr. Wheatley made a motion to invest \$100,000 into 3-5 year certificates of deposit (CDs). Mr. Shackelford seconded the motion, and it passed without dissent. Mr. Hodapp will contact Fifth Third Brokerage and arrange for the purchase of two \$50,000.00 CDs.

#### MINUTES:

Mr. Shackelford made a motion to approve the Minutes of the Regular Council Meeting held on October 4, 2016. The motion was seconded by Mr. Hoard, and it passed without dissent.

#### TREE BOARD:

Ms. Jane Ecker of the Tree Board attended the meeting and discussed the following:

- 27 residents have requested trees for the fall 2016 planting. The plantings should take place within the next 45 days;
- 44 residents have applied for tree maintenance funding.
- Ms. Ecker will obtain information on Tree City USA signage.

### **POLICE REPORT:**

The KLE Small City Activity Report for the month of October will be published in the December newsletter.

### **CITY ENGINEER'S REPORT: MEL MILBURN (Absent)**

Although Mr. Milburn was absent, he sent a message he was experiencing problems locating a contractor for the sidewalk project at 2605 Foxy Poise Road. The contractors he normally uses are booked until the end of the year, and this being such a small project, he's experiencing difficulty locating another contractor. He will continue his efforts.

Mr. Schweickhardt said it was his understanding MSD had repaired the storm drain blockage in the vicinity of 4308 St. Regis Lane. He will follow-up at the next heavy rain.

### **CITATION OFFICER'S REPORT: KENNY BETTS**

In October, Mr. Betts patrolled 104 miles, issued 8 Hi-Neighbor notices, received 2 complaints and conducted 13 house visits/communications.

The City has "No Parking" signs available for use by residents who host large gatherings. Residents may call City Clerk Bill Hodapp at 654-8145 for information regarding the use of these signs.

### **CITY ATTORNEY'S REPORT: JOHN SINGLER**

Mr. Singler introduced the 2nd Reading of Ordinance 3, 2016-2017, which will adopt the American Legal Code of Ordinances, Supplemental 2016 S-7 series. Mr. Allen made a motion to approve the adoption of the ordinance. Ms. Willett seconded the motion, and it passed without dissent by roll call vote.

Mr. Singler also discussed the Google Fiber project and a zoning meeting on November 14, 2016 for a proposed construction in Houston Acres.

Based on an audit recommendation, Mr. Singler suggested the Mayor and City Clerk-Treasurer be bonded for \$300,000.00 each. The Council agreed with the bonding limits. Mr. Hodapp will contact KLC to arrange for bonding.

### **PUBLIC WORKS**: LOUIE SCHWEICKHARDT

Mr. Schweickhardt will follow-up with MSD regarding any possible storm water issues on St. Regis Lane.

### **SPECIAL EVENTS**: TALBOTT ALLEN

The annual holiday celebration will be held from 4:00-6:00 p.m. on Sunday, December 11, 2016, at the St. Andrew United Church of Christ at 2608 Browns Lane. Food, prizes and Santa will be present.

The annual holiday decoration contest will also take place and appropriate information will be again published in the December newsletter.

We can often become so distracted by the lists in our heads, kids at our heels, and work left undone that we lose sight of our personal safety. You may have read them before but a refresher is always a good idea. Here are a few things to consider:

### BE AWARE OF YOUR SURROUNDINGS.

### **BRANCHING OUT**

What a sunny and beautiful Autumn we are having! It's been great for getting outside and enjoying the gorgeous tree color, but after a relatively wet Spring and Summer, we are now in almost drought conditions. Please keep your new and established trees appropriately watered.

Speaking of water, if your "new" tree is now two years old, but your tree bag is still good, please drop it off on the back porch of 2602 Aintree Way. We will re-use it for the next generation of new trees.

Fall is also a good time to make sure your tree is still mulched. It is not necessarily a good idea to plant flowers under your new tree — they will compete for vital water and nutrients while your tree roots are still close to the surface. Also, remember: Don't make your mulch look like a cone — just a nice flat layer of 2-4 inches of mulch, stopping within two inches of the tree trunk to allow it to breathe.

If you are going to purchase a live Christmas tree to plant in your yard after Christmas, please keep it well watered while it is inside and plant it as soon as possible, following directions you should be able to find easily online.

Our Fall tree planting is happening very soon — we hope you will stop and read the tags to see the amazing quality and variety of our new trees! As we celebrate Thanksgiving, we are grateful for our forward-thinking Mayor and City Council and our wonderful citizens who have supported our new tree planting and maintenance programs. ### **Independent Auditor's Report**

The Honorable Mayor and Council of the City of St. Regis Park, Kentucky

### Report on the Financial Statements

We have audited the accompanying financial statements of the governmental activities and each major fund of the City of St. Regis Park, Kentucky as of and for the year ended June 30, 2016, and the related notes to the financial statements, which collectively comprise the City's basic financial statements as listed in the table of contents.

### Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

### Auditor's Responsibility

Our responsibility is to express opinions on these financial statements based on our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risk of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. Accordingly, we express no such opinion. An audit also includes evaluating the appropriateness of accounting policies and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinions.

### **Opinions**

In our opinion, the financial statements referred to above present fairly, in all material respects, the respective financial position of the governmental activities and each major fund of the City of St. Regis Park, Kentucky at June 30, 2016, and the respective changes in financial position for the year then ended in accordance with accounting principles generally accepted in the United States of America.

### **Other Matters**

### **Required Supplementary Information**

Accounting principles generally accepted in the United States of America require that the management's budgetary comparison information on page 18 be presented to supplement the basic financial statements. Such information, although not a part of the basic financial statements, is required by the Government Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We have applied certain limited procedures to the required supplementary information in accordance with auditing standards generally accepted in the United States of America, which consisted of inquiries of management about the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

Management has omitted the Management's Discussion and Analysis that accounting principles generally accepted in the United States of America has required to be presented to supplement the basic financial statements. Such missing information, although not a part of the basic financial statements, is required by the Government Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. Our opinion on the basic financial statements is not affected by this missing information.

### Other Reporting Required by Government Auditing Standards

In accordance with Government Auditing Standards, we have also issued our report dated October 19, 2016, on our consideration of the City of St. Regis Park, Kentucky's internal control over financial reporting and on our test of its compliance with certain provisions of laws, regulations, contracts and grant agreements and other matters. The purpose of that report is to describe the scope of our testing of internal control over financial reporting and compliance and the result of that testing and not to provide an opinion on the internal control over financial reporting or on compliance. That report is an integral part of an audit performed in accordance with Government Auditing Standards in considering the City's internal control over financial reporting and compliance.

### CITY OF ST. REGIS PARK, ORDINANCE #3, SERIES 2016-2017 ORDINANCE ENACTING AND ADOPTING A SUPPLEMENT TO THE CODE OF ORDINANCES OF THE CITY OF ST. REGIS PARK, KENTUCKY

**WHEREAS**, American Legal Publishing Corporation of Cincinnati, Ohio has completed the 2016 (S-7), supplement to the Code of Ordinances of the City of St. Regis Park, which supplement contains all ordinances of a general nature enacted since the prior supplement to the Code of Ordinances of this municipality; and

**WHEREAS**, American Legal Publishing Corporation has recommended the revision or addition of certain sections of the Code of Ordinances which are based on or make references to sections of the Kentucky Revised Statutes;

**WHEREAS**, it is the intent of Council to accept these updated sections in accordance with the changes of the law of the Commonwealth of Kentucky;

NOW, THEREFORE, BE IT ORDAINED by the City of St. Regis Park:

**SECTION 1.** That the 2016 (S-7), supplement to the Code of Ordinances of the City of St. Regis Park, Kentucky, as submitted by American Legal Publishing Corporation of Cincinnati, and as attached hereto, be and the same is hereby adopted by reference as if set out in its entirety.

**SECTION 2.** That this Ordinance shall take effect and be in full force from and after its date of passage, approval, and publication as required by law.


