### CITY OF ST. REGIS PARK **MINUTES OF THE REGULAR** MONTHLY COUNCIL MEETING

February 7, 2017

Following are the Minutes of the regular monthly Council Meeting for the City of St. Regis Park, held at 7:00 p.m., Tuesday, February 7, 2017 at 4318 Taylorsville Road, Louisville, Kentucky 40220.

#### **ROLL CALL:**

Present: Mayor Brandt Davis; Council Members: Talbott Allen, Bob Graves, Louie Schweickhardt, Jeff Weis, Frank Wheatley, and Cheryl Willett. Absent: Eric Shackelford.

#### MAYOR'S REPORT:

No Report.

#### FINANCIAL REPORT:

Mr. Charles J, Veeneman, CPA, City Accountant, presented the Financial and Investment Report for January 2017. General Fund revenues for the month were \$15,814.20 with year-to-date revenues at \$336,448.59. Total expenses for the month were \$22,363.81 with year-to-date expenses at \$208,403.68 resulting in year-to-date revenues over expenses of \$128,044.91.

Road Fund revenues for the month were \$2,619.36 with yearto-date revenues at \$17,766.55. Total expenses were \$1,900.00 with year-to-date expenses at \$1,900.00 resulting in year-to-date excess revenues of \$15,866.55.

Year-to-date interest earned on investments was \$1,490.46.

Mr. Allen made a motion to approve the January 2017 Financial Report. The motion was seconded by Ms. Willett, and it passed without dissent.

#### **MINUTES:**

Mr. Graves made a motion to approve the Minutes of the Regular Council Meeting held on January 3, 2017. The motion was seconded by Ms. Willett, and it passed without dissent.

#### TREE BOARD:

Mr. Joe Hinkle of the Tree Board attended the meeting and discussed the following:

- The Tree Board members have declined the offer of compensation from the City.
- The 2017 Arbor Day city celebration will be held at Ascension on Saturday, April 22nd. More information will be included in the newsletter and on the website.
- Twelve residents have requested trees for the spring planting.

#### POLICE REPORT:

The KLE Small City Activity Report for the month of January will be published in the March newsletter.

Mr. John Aubrey of Kentuckiana Law Enforcement attended the meeting and discussed additional services his company could provide to the City.

#### **CITY ENGINEER'S REPORT: MEL MILBURN**

Mr. Milburn will meet with the property owner on Foxy Poise to discuss repairing the concrete apron and sidewalk. The City will be responsible for repairing the sidewalk and Mr. Milburn will inquire if the resident wishes to repair the apron at the same time. Separate invoicing and contracts will be required. Mr. Milburn will also: a) inspect all City streets for extensive damage and b) research a coating that will adhere to the curbs for street addresses.

#### **CITATION OFFICER'S REPORT: KENNY BETTS**

In January, Mr. Betts patrolled 109 miles, issued 9 Hi-Neighbor notices, received 16 complaints and conducted 16 house visits/ communications.

#### **CITY ATTORNEY'S REPORT: JOHN SINGLER**

Mr. Singler presented a draft of the sanitation bid specifications that will be issued in February. Council Members reviewed the draft and offered the following input for the bid specifications.

The bid specifications will include:

- Weekly curbside and rear-door collections.
- Weekly collection of recycling materials.
- Year-round weekly collection of yard waste.

# **BRANCHING OUT**

Before you know it, it will be Spring, and to your Tree Board members, that of course, means time to think (even more!) about trees! We'd like

to take this opportunity to remind you of our top three priorities for the coming months:

- 1. Save the Date for Arbor Day 2017—This year's celebration will be Saturday, April 22nd, at 2 PM, at a location to be announced. We hope you will join us to hear Cindi Sullivan, our City Arborist, give an update on our tree canopy and other tree issues. You'll also have an opportunity to ask questions of Cindi and the Tree Board members.

Cindi will then put a flag in your yard where she thinks a tree would work. You have the chance to contact her if you have any concerns. When everything is settled, your yard will be marked for utilities, and the tree will be planted shortly thereafter. If you do not use email, call that information into the city phone line, 491-7777. To get a head start, fill out the Memorandum of Agreement, available below and on our website, retreethepark.com, and mail it to Joe Hinkle, 2605 Hurdle Way, 40220.

#### **Tree Planting Memorandum of Agreement**

As a resident of St. Regis Park, I agree to give the City of St. Regis Park (and its agents) my permission to enter my premises for the purpose of planting trees and release them from liability for same and further agree that any and all future maintenance of any planted tree or trees is my responsibility. I agree to maintain my new tree(s) to the best of my ability using the guidelines provided by the city arborist.

I will ensure that my tree(s) receive a regular thorough soaking of the soil in the root zone, and that the soil is kept consistently moist (but not wet) until the tree is well established.

I will ensure that my tree(s) maintain a healthy 2-3 inch layer of mulch over the root zone and that the mulch is kept from touching the trunk.

3. Do You Need Maintenance on Your Tree, or Advice About the Health of Your Trees? We still have money available in the funds allocated by the Mayor and City Council for tree maintenance and the removal of dead trees. Here's the policy and procedure, if you are interested in work in your front, side, or back yard: You may qualify for a one-time reimbursement of 40%, up to \$500, per household, per year, for tree maintenance (pruning, treatment, bracing, etc.) or removal of a dead or dying tree, as long as allocated funds are available. Work must be approved by the city arborist and performed by a qualified, insured, and bonded tree contractor, with a certified arborist on staff. To participate in this program, residents must submit a request to the Tree Board (see above for Mary Mattingly's email) with your name, address, phone, email, and the work you think needs to be done. The Tree Board will review and approve the applications to participate in the program based upon the arborist's evaluation and balance of funds allocated to the program. You may pick your own qualified tree service, but here is a list that residents have used recently:

## **INFORMATION TO IMPROVE HOMEOWNERSHIP** MORTGAGE LOANS FROM RELATIVES

Occasionally, when dealing with close relatives who might also become heirs, signing a note and handling the paperwork properly may seem like a needless effort but it could mean the difference in being able to take a legitimate interest deduction.

Home mortgage interest is deductible only if the loan is a secured and 3) the home is sufficient collateral for the loan. debt which involves the buyer signing an instrument like a mortgage or deed of trust that makes the ownership of the home It would be prudent to consult with an attorney before you sign security for the debt. That instrument must then be recorded or the final settlement papers to be comfortable that both the buyer otherwise perfected according to state or local law and the home, and the lender-relative are complying with IRS regulations. in case of default, must be able to satisfy the debt.
