The **St. Regis Park Tree Board** continues to move forward. An additional 25 new trees are to be planted this fall bringing the total number of plantings to 200 since the inception of the program. In addition, there are some 20 active maintenance requests being processed. The City of St. Regis Park continues to demonstrate its commitment to caring for and managing our trees and shrubs.

There continue to be occasional "break-ins" of cars parked either in driveways or on the street. # CITY OF ST. REGIS PARK MINUTES OF THE REGULAR MONTHLY COUNCIL MEETING

September 5, 2017

Following are the Minutes of the regular monthly Council Meeting for the City of St. Regis Park, held at 7:00 p.m., Tuesday, September 5, 2017, at 4318 Taylorsville Road, Louisville, Kentucky 40220.

### **ROLL CALL:**

Present: Mayor Brandt Davis; Council Members: Talbott Allen, Bob Graves, Eric Shackelford, Louie Schweickhardt, Frank Wheatley, and Jeff Weis.

Absent: Cheryl Willett.

### **MAYOR'S REPORT:**

Mayor Davis discussed the following:

- a) Speeding the solar powered digital speed limit sign should be delivered in September. Mayor Davis requested feedback to reducing the speed limit to 20 MPH in the city. Mr. Singler advised that the Kentucky court system could not enforce a citation for speeding less than 25 MPH. No further action was taken.
- b) A meeting was held with MSD to discuss the placement of rip rap along the banks of Weicher Creek near Lincoln Road in order to control erosion. MSD stated that vegetation is the best option to control erosion and has no plans to place the rip rap.
- c) New street signs will be ordered in September.

### **FINANCIAL REPORT:**

Mr. Charles J, Veeneman, CPA, City Accountant, presented the Financial and Investment Report for August 2017. General Fund revenues for the month were \$77,377.41 with year-to-date revenues at \$97,875.45. Total expenses for the month were \$22,846.81 with year-to-date expenses at \$63,267.51 resulting in year-to-date revenues over expenses of \$34,607.94.

Road Fund revenues for the month were \$2,533.07 with year-to-date revenues at \$5,288.30. Total expenses were \$0 with year-to-date expenses at \$0 resulting in year-to-date excess revenues of \$5,288.30.

Year-to-date interest earned on investments was \$3,822.87.

Mr. Graves made a motion to approve the August 2017 Financial Report. The motion was seconded by Mr. Shackelford, and it passed without dissent.

### **MINUTES:**

Mr. Allen made a motion to approve the Minutes of the Regular Council Meeting held on August 1, 2017. The motion was seconded by Ms. Shackelford, and it passed without dissent.

### **POLICE REPORT:**

No Report.

The KLE Small City Activity Report for the month of August 2017 will be published in the October newsletter.

### CITY ENGINEER'S REPORT: MEL MILBURN (Absent)

Mr. Milburn will review the placement of speed humps on Woodward Way and determine the location.

The sidewalk replacement on Foxy Poise has been completed.

### CITATION OFFICER'S REPORT: STEPHEN HOARD

In August, Mr. Hoard patrolled 45 miles and issued thirty-three (33) notices.

Mr. Hoard tendered his resignation to the Council but advised he would remain in the position until a replacement was found. The open job position will be posted in the October newsletter and on the city Facebook page and website.

### **CITY ATTORNEY'S REPORT: JOHN SINGLER**

Mr. Singler advised that a resident on Lynnbrook Drive requested no repairs be made to his sidewalk during the recent project to address trip hazards under the ADA guidelines. The sidewalk is in the City of Louisville right-ofway and not part of St. Regis Park. No repairs were made per the resident's request.

Mr. Singler is addressing concerns related to a resident that may be running an illegal business out of a home on Lincoln Road.

### **BUILDING PERMITS: LOUIE SCHWEICKHARDT**

A permit was issued for a deck at 4503 Statton Road.

Mr. Andy King who resides at 4503 Statton Road attended the meeting and requested a variance to construct a shed that will be 10 ½ high. The Council reviewed the plans, and a motion was made by Mr. Schweickhardt to approve the variance. The motion was seconded by Mr. Wheatley, and it passed without dissent.

#### SPECIAL EVENTS: TALBOTT ALLEN

The city-wide yard sale is scheduled for Saturday September 9, 2017.

**PUBLIC SAFETY: CHERYL WILLETT** (Absent) No report.

The City has "No Parking" signs available for use by residents who host large gatherings.

### **PUBLIC WORKS: ERIC SHACKELFORD**

A resident on Aintree Way reported her driveway was damaged during the recent sidewalk repair project. Mr. Shackelford will contact Precision Concrete and have them contact the resident directly to address the issue.

MARKETING/IT: FRANK WHEATLEY No Report.

### **COMMUNICATIONS FACILITATOR: BOB GRAVES**

Mr. Graves addressed the following issues:

- Some residents believe the curbs in the front of their homes are in the right-of- way and it is not their responsibility to maintain (trim/edge) the grass. Mr. Singler advised that it is the resident's responsibility to maintain the curbs.
- Rumpke is to be informed that the yard waste employees are too aggressive with the handling of the yard waste cans.
- The vegetated area along the barrier wall behind Riders Row Court, Stormon Court and Hedgerow Court has not been cut by the State. The city and residents in the area will continue to contact the State regarding this matter.

**FINANCE: JEFF WEIS** 

Mr. Weis reviewed the bank statements for July 2017 and found no issues in the reconciliation process.

### TREE BOARD:

Ms. Mary Mattingly of the city Tree Board attended the meeting. Twenty-five residents have requested trees in the fall of 2017.

A resident on Hedgerow Court requested reimbursement

for tree maintenance that he had done due to damage from a storm. The resident did not receive prior approval to remove the damaged portion of the tree and is not subject to reimbursement.

### ADJOURN:

There being no further business, Mr. Allen made a motion to adjourn. The motion was seconded by Mr. Shackelford, and it passed without dissent. The meeting adjourned at 8:07 p.m.

## **BRANCHING OUT**

Soon it will be Fall! If there is any one thing we associate with Fall, it is trees — beautiful autumn colors and falling leaves crunching under our feet! It is gratifying to reflect on the wonderful attention that St. Regis Park and its residents are paying to our trees. Whether it is choosing to plant a new tree or maintaining an old one, our city leadership and citizens continue to lead the way!

Fall tends to be dry here, so please be aware that all trees need water through November. Even if we get rain, your tree will not get the full benefit unless you have kept it mulched. If your tree came from the city, please recall that part of your agreement was to keep the tree mulched for the life of the tree. Please use the  $3 \times 3 \times 3$  mulching rule for ALL trees: Spread 3 inches of much in a 3 foot circle around the tree and leave 3 inches free around the trunk for the tree to breathe. Coning of mulch against the tree can be harmful. Even if we did not purchase and plant your trees, we certainly

hope you will keep them mulched!

Speaking of November — Thanksgiving is usually the safe time to take the Gator bag off your tree — if this was your first year, hold onto it, and put it back on around St. Patrick's Day. If your tree has been planted a full two years and your bag is still good, feel free to drop it off on the back porch of 2602 Aintree Way.

As always, we continue to take new tree and maintenance requests. We really hope to plant 25 trees this Fall — that would take us over 200 new trees planted! Won't you help us, the look of your lawn, and your energy bills by planting a tree? Thanks for considering it.

### INFORMATION TO IMPROVE HOMEOWNERSHIP

YOUR HOME'S EQUITY COULD BE THE ANSWER

A home equity line of credit, HELOC, is a mortgage loan made to homeowners to be used on an as-needed basis. A lender, such as a bank, will approve a borrower for a specified amount based on the equity in their home and all the necessary paperwork is signed to authorize the loan.

The line of credit amount is available to the borrower and no interest is due until some or all the money is used. When the money is paid back, the line of credit is again available in full to the borrower.

The specifics of the repayment will depend on the HELOC lender. It may require interest only or it may require amortized payments of principal and interest.

The proceeds from a HELOC can be used to make improvements on the home or anything else such as medical expenses, college tuition or unexpected expenses or other liquidity issues.

Unlike personal credit card interest, the interest on a HELOC may be tax deductible. Your tax advisor will be able to let you know about your particular situation.

Rates and fees can vary widely on HELOC loans. Borrowers should shop around, compare and get recommendations before deciding on a lender.
