Dear Fellow Residents:

As many of you may have heard, Oxmoor Country Club has created some additional ways for families of St. Regis Park to join at reduced rates. For example, some families may not be interested in golf, but may like the idea of joining just for the pool. If that is the case, there is a reduced rate for that. I received an email from a fellow citizen that read, "It is important to our community to understand that Oxmoor CC could cease to exist as we now know it, if at all. While many of us don't actually live on the golf course, a change in that land usage could affect us all. The future of Oxmoor is important as changes would affect our wonderful neighborhood, as well as jeopardizing property values. If the Country Club fails, the land that the golf course occupies could become, subdivisions, apartments or other uses. It would

be regrettable, if support from our community could have prevented these changes if only we had been aware of the consequences. Support from our city could help Oxmoor thrive and continue to be an asset for St. Regis." As the mayor of St. Regis Park, I would simply encourage you to look in to the options that Oxmoor Country Club offers and see if any of their options would be right for you and your family.

**MINUTES OF THE REGULAR MONTHLY COUNCIL MEETING**  
**February 6, 2018**

Following are the Minutes of the regular monthly Council Meeting for the City of St. Regis Park, held at 7:00 p.m., Tuesday, February 6, 2018, at 4318 Taylorsville Road, Louisville, Kentucky 40220.

**ROLL CALL:**

Present: Mayor Brandt Davis; Council Members: Talbott Allen, Bob Graves, Eric Shackelford, Louie Schweickhardt, Frank Wheatley, Jeff Weis, and Cheryl Willett.

Absent: None.

**MAYOR'S REPORT:**

Mr. Bob Graves will be moving from St. Regis Park and has submitted his resignation effective March 7, 2018. Mr. Shackelford made a motion to accept the resignation. Ms. Willett seconded the motion and it passed, with Mr. Graves abstaining.

The City will advertise in the March newsletter in order to fill the vacant council position at the March 6, 2018 meeting. Candidates must submit their resume by February 28, 2018 and interviews will take place prior to the March council meeting.

Mr. Schweickhardt made a motion to move the April 2018 council meeting from April 3, 2018 to Thursday, March 29, 2018 at 7:00PM. Mr. Wheatley seconded the motion and it passed without dissent.

**FINANCIAL REPORT:**

Ms. Gloria Curran, an employee of the Charles J. Veeneman Accounting firm presented the Financial and Investment Report for January 2018. General Fund revenues for the month were \$21,624.05, with year-to-date revenues at \$355,986.76. Total expenses for the month were \$21,166.65, with year-to-date expenses at \$228,712.33, resulting in year-to-date revenues over expenses of \$127,274.43.

Road Fund revenues for the month were \$2,643.82, with year-to-date revenues at \$18,115.17. Total expenses were \$1,105.60, with year-to-date expenses at \$1,105.60, resulting in year-to-date revenues over expenses of \$17,009.57.

Year-to-date interest earned on investments was \$9,467.68.

Mr. Allen made a motion to approve the January 2018 Financial Report. The motion was seconded by Mr. Shackelford and it

passed without dissent.

**MINUTES:**

Mr. Shackelford made a motion to approve the Minutes of the Regular Council Meeting held on January 2, 2018. The motion was seconded by Mr. Schweickhardt. It passed without dissent.

**CITY ENGINEER'S REPORT: MEL MILBURN (Absent)**

**CITATION OFFICER'S REPORT: JASON LEWIS**

Mr. Lewis presented the January 2018 report and reviewed current issues.

**CITY ATTORNEY'S REPORT: JOHN SINGLER**

Mr. Singler presented an addendum from the Jefferson County League of Cities to amend the Fiber Optic ordinance. Mr. Singler advised against entering into the revised agreement at the current time. The council agreed and will review additional information at future meetings. Mr. Singler also discussed tax collection matters.

Mr. Schweickhardt has been meeting with LG&E and will obtain an updated contract for the replacement of the street light fixtures throughout the city.

### Tree Planting Request

As a resident of St. Regis Park, I agree to give the City of St. Regis Park (and its agents) my permission to enter my premises for the purpose of planting trees and release them from liability for same and further agree that any and all future maintenance of any planted tree or trees is my responsibility. I agree to maintain my new tree(s) to the best of my ability using the guidelines provided by the city arborist.

I will ensure that my tree(s) receive a regular thorough soaking of the soil in the root zone, and that the soil is kept consistently moist (but not wet) until the tree is well established. I will ensure that my tree(s) maintain a healthy 2-3 inch layer of mulch over the root zone and that the mulch is kept from touching the trunk.

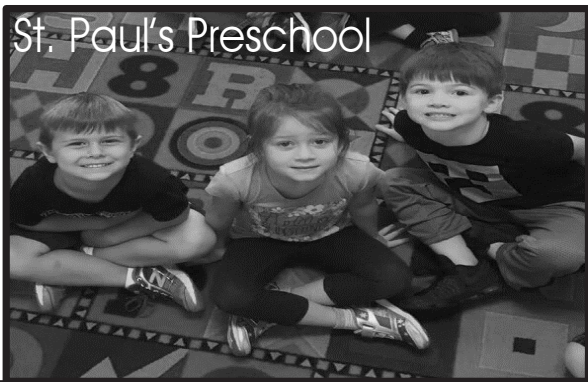

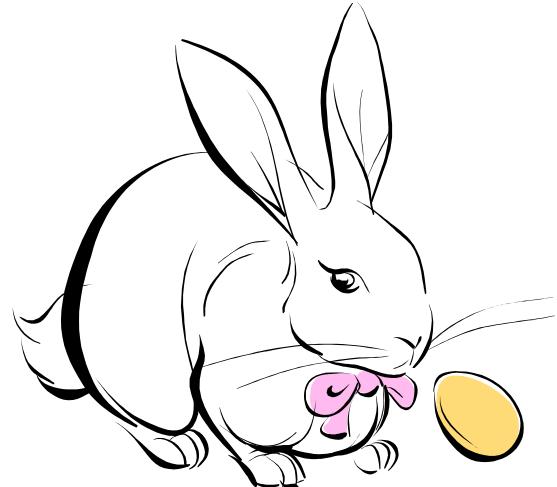

# PUBLIC SAFETY CORNER

## COLD WEATHER SAFETY

As temperatures drop, here are several tips to keep you and your loved ones safe.

### PROTECT PEOPLE

- Keep warm. Stay inside if at all possible.
- If you need to go out, dress in layers and wear hats, gloves and an appropriate coat.
- Avoid overexertion as cold weather puts an added strain on your body, but try to stay active in order to maintain body heat.
- When your extremities feel numb, go inside to warm.
- Never place a space heater on top of furniture or near water. Keep heat sources least three feet from furniture and drapes.
- Never leave children unattended near a space heater.

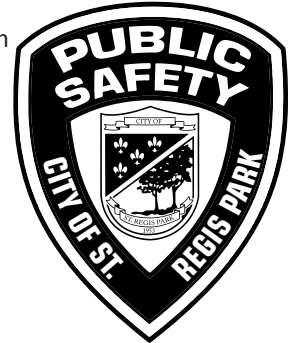
### PROTECT PETS

- Don't leave your pets outside when temperatures drop.
- Appropriate action should be taken for outdoor pets. Provide adequate protection from cold temperatures or bring them indoors.
- Make sure your pet's water is not frozen

### PROTECT PIPES

- Wrap exposed faucets and pipes, including those outside the house. If you don't have the foam pipe coverings, a towel or rag and duct tape will do the trick.
- Let your indoor faucets drip.
- Open cabinet sinks to allow the heat top to circulate around the water pipes.

- Make sure you know where your home's shut-off valve is and how to turn it on and off. If a pipe bursts it could flood your home. Turn the water off at the shut-off valve.



### PROTECT PLANTS

- Bring your smaller container plants indoors. Mulch or cover outdoor plants with straw, blankets or cardboard.
- To prevent heat loss from containers, push together large outdoor pots and wrap the bases with plastic, burlap or a blanket.
- Be sure to turn off automatic sprinklers, detach hoses from outdoor faucets and wrap the faucets to protect outdoor plants.
