CITY OF ST. REGIS PARK MINUTES OF THE REGULAR MONTHLY COUNCIL MEETING

June 5, 2018

Following are the Minutes of the June 2018 Council Meeting for the City of St. Regis Park, held at 7:00 p.m., Tuesday, June 5, 2018, at the McMahan Fire Station located at 4318 Taylorsville, Louisville, Kentucky 40220.

ROLL CALL:

Present: Mayor Brandt Davis; Council Members: Kacy Noltemeyer, Louie Schweickhardt, Eric Shackelford, Frank Wheatley, Jeff Weis, and Cheryl Willett.

Absent: John Amback

MAYOR'S REPORT:

Joe and Corri Fierro, new residents in the city, attended the meeting and Corri offered to volunteer her time for special projects the city may need assistance with. The council will review upcoming events and contact Corri for assistance.

J. Mark Madison of the Milestone Design Group attended the meeting and presented his companies qualifications for engineering services for the city.

Mr. Weis made a motion to approve the Second Reading of *Ordinance 3, Series 2017-2018, an Ordinance adopting the 2040 Comprehensive Plan (Case No. COMP_Plan_Update_4.16.18).* Mr. Shackelford seconded the motion and it passed without dissent.

Mr. Weis made a motion to approve the Second Reading of *Ordinance 1, Series 2018-2019, an Ordinance establishing an Ad Valorem Tax of .117 and a Sanitation Rate of \$190.80/household.* The motion was seconded by Mr. Schweickhardt and it passed without dissent.

Ms. Willett made a motion to approve the Second Reading of *Ordinance 2, Series 2018-2019, an Ordinance adopting the 2018-2019 Fiscal Budget.*Mr. Weis seconded the motion and it passed without dissent.

FINANCIAL REPORT:

Mr. Charles J. Veeneman, the city accountant presented the Financial and Investment Report for May 2018. General Fund revenues for the month of May were \$27,604.69 with year-to-date revenues at \$407,119.94. Total expenses for the month were \$25,495.58, with year-to-date expenses at \$319,716.66, resulting in year-to-date revenues over expenses of \$87,403.28.

Road Fund revenues for the month were \$2,564.84, with year-to-date revenues at \$27,777.53. Total expenses were \$2,925.00, with year-to-date expenses at \$10,930.60, resulting in year-to-date revenues over expenses of \$16,846.93.

Mr. Shackelford made a motion to approve the May 2018 financial and investment reports. Mr. Weis seconded the motion and it passed without dissent.

Ms. Willett made a motion to approve the May Minutes of the Regular Council Meeting held on May 2, 2018. The motion was seconded by Mr. Schweickhardt and it passed without dissent.

CITY OF ST. REGIS PARK ORDINANCE NO 1, SERIES 2018-2019 AN ORDINANCE PROVIDING FOR THE ASSESSMENT OF AN AD VALOREM TAX AND A SANITATION TAX

WHEREAS, in order to provide revenue for general governmental purposes and operation, with manner of assessment and collection of said taxes; and

WHEREAS, to provide the assessment of all real property within the City corporate limits as of January 1, 2018; and

WHEREAS, the provisions for the levy and collection of these taxes shall apply for a period starting on July 1, 2018 and ending June 30th, 2019.

NOW THEREFORE, the council of the City of St. Regis Park does ordain as follows:

Section 1:

The assessment of said real property shall be the valuation as listed on the Jefferson County Property Valuation tax records as of January 1 st, 2018 and is hereby adopted as the assessment for ad valorem tax purposes.

Section 2:

To levy an ad valorem tax of all real property and property of utility companies as allowed by law at the rate of \$. 1 17 cents per one hundred dollars of the assessed value. Section 3:

To levy a special sanitation tax assessment under KRS 82.095 on every residence within the City at the rate of \$190.80 per household.

Section 4:

Said taxes shall be due and payable to the "City of St. Regis Park" and mailed to the City of St. Regis Park, C/O River City Bank, 2501 Bardstown Road, Louisville, KY 40205, as follows: July 15 through September 30th the discounted amount (5% discount off face amount). Face amount to October 31 st. November 1 and thereafter, face amount of total bill, plus fifteen percent (15%) penalty, plus an additional one percent (1%) interest charge compounded per month starting November 1, 2018. November 1, 2018 the tax bill becomes delinquent and collection of said taxes shall be made in the manner prescribed by law. Failure to pay the tax and penalty shall and will constitute a lien upon the property in question.

Section 5:

The revenue from said taxes, interest and penalties shall be used for the general operating expenses of the City and for the general purposes for the City in the discharge of its municipal functions as ordained, resolved or directed by the City Council of St. Regis Park. Any surplus from said taxes shall go to the general operation fund of the City.

Section 6:

This ordinance shall be effective upon passage and publication.

ORDINANCE NO. 3 _____, SERIES 2018 AN ORDINANCE ADOPTING THE PLAN 2040 COMPREHENSIVE PLAN (CASE NO. COMP_PLAN_UPDATE_4.16.18)

WHEREAS, in August of 2016, an advisory committee was established representing various agencies, organizations, and interests of the community to guide the update of Louisville Metro's comprehensive plan;

WHEREAS, between August, 2016 and March, 2018, a broad and inclusive public engagement process was conducted, consisting of over 160 public meetings, during which input was collected from over 6,000 participants, to ensure the comprehensive plan appropriately reflects the community's vision for the future growth and development;

WHEREAS, using Cornerstone 2020 as its foundation, the comprehensive plan update focused primarily on five guiding principles: connectivity, healthy, authenticity, sustainability, and equity;

WHEREAS, the comprehensive plan update is based on research and analysis of the community's existing conditions and trends, as required by KRS Chapter 100, including but not limited to (1) the general distribution of past and present population and a forecast of the extent and character of future population; (2) an economic survey and analysis of the major existing public and private business activities, and a forecast of future economic levels, including a forecast of anticipated necessary actions by the community to increase the quality of life of its current and future population through the encouragement of economic development; and (3) the nature, extent, adequacy and the needs of the community for the existing land and building use, transportation, and community facilities in terms of their general location, character and extent; all as set forth in the demographic and economic assessment completed in 2015 by the University of Louisville's Urban Studies Institute and the Kentucky State Data Center, a copy of which is included as an appendix to the comprehensive plan update;

WHEREAS, the comprehensive plan update, entitled Plan 2040, contains Goals and Objectives, and Land Use (Community Form), Transportation (Mobility), and Community Facilities Plan Elements, as required by KRS Chapter 100, as well as Economic Development, Housing, and Livability Plan Elements; and

WHEREAS, on April 16, 2018, in case No. Comp_Plan_Update_4.16.18, the Louisville Metro Planning Commission held a duly-noticed public hearing on, and recommended approval of, the Plan 2040 Comprehensive Plan;

WHEREAS, the City Council of the City of St. Regis Park has reviewed the minutes and records of the Planning Commission and the Plan 2040 Comprehensive Plan, and concurs in the recommendation of the Planning Commission;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF ST. REGIS PARK COUNCIL AS FOLLOWS:

SECTION I: There is hereby adopted the Plan 2040 Comprehensive Plan, which is attached hereto and incorporated in this Ordinance as if fully set forth herein.

SECTION II: The adoption of the Plan 2040 Comprehensive Plan herein shall repeal and replace the Cornerstone 2020 Comprehensive Plan as of September 1, 2018, and shall become applicable on said date.

SECTION III: This Ordinance shall take effect on upon its passage and approval.




