December 4, 2018

Following are the Minutes of the December 2018 Council Meeting for the City of St. Regis Park, held at 7:00 p.m., Tuesday, December 4, 2018, at the Jeffersontown Fire Station located at 4318 Taylorsville, Louisville, Kentucky 40220.

ROLL CALL:

Present: John Amback, Kacy Noltemeyer, Louie Schweickhardt, Frank Wheatley and Cheryl Willett.

Absent: Brandt Davis, Eric Shackelford, Jeff Weis

MAYOR'S REPORT:

Mayor Davis was absent and Mr. Amback made a motion to appoint Ms. Willett as mayor pro tem. Mr. Schweickhardt seconded the motion and it passed without dissent.

FINANCIAL REPORT:

Mr. Charles J. Veeneman, the city accountant presented the Financial and Investment Report for November 2018. Mr. Wheatley made a motion to approve the November 2018 financial and investment reports. Mr. Amback seconded the motion and it passed without dissent. Copies of the monthly financial reports are available on the city website.

Mr. Schweickhardt made a motion to transfer the cash from the non-interest bearing Fifth Third Brokerage account to the interest bearing money market account at River City bank. The motion was seconded by Mr. Amback and it passed without dissent.

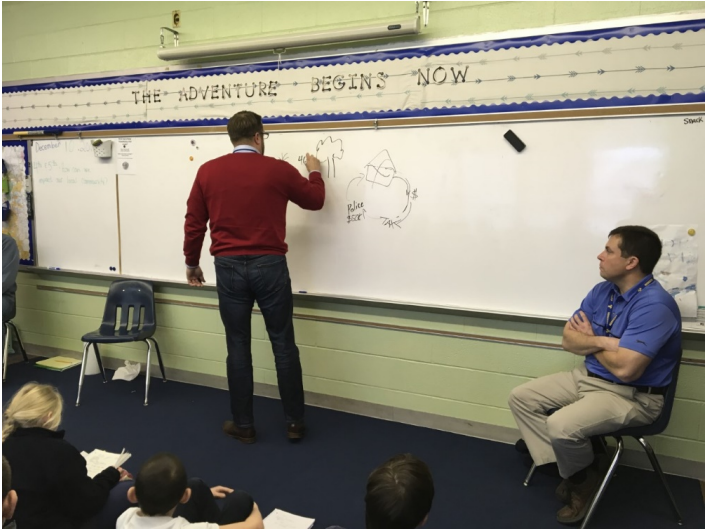
