Dear Fellow Residents:

I don't know about the rest of you, but I am eagerly anticipating Spring. Even as I type this my toes are chilled. I long for the blue skies and green grass to come back soon. I am hopeful that it is right around the corner, as I did see the most beautiful cardinal perched on my lamp post a few days ago.

In relationship to spring, let's discuss some "Spring Cleaning" that needs to occur. As I walk the neighborhood, I see quite a few yards that still have a lot of leaves in them. I have had quite a few complaints this year where citizens are frustrated that they have raked their leaves, just to have a neighbor's leaves (who did not rake appropriately) blow in their yard. Please be considerate and rake your leaves accordingly.

Also, please make sure that your curb and storm drains remain clear of leaves and other debris. Number 1, it looks nice. Number 2, our storm drains sometimes struggle to handle all the water we receive if it rains heavily all at once. This is compounded even more when the storm drains are partially clogged from sticks, twigs, leaves, etc.

Next, as Mayor of our city, I take a strong stand in valuing our city's tree canopy. In my work in the insurance industry, I evaluate hundreds of homes each month, and I can tell you that a community with a healthy tree canopy is a community where people are out walking and chatting with their neighbors, a community with healthy and active citizens, one with lower crime rates and higher home values. Trees are part of the infrastructure of any community, as surely as the roads, sidewalks, and street lights. Enhancing the tree canopy of St. Regis Park is a priority of our city council, and we are proud to support the efforts of the tree board and our city arborist. In the last several years, we have spent approximately \$40-50k annually and added a total of approximately 223 trees to our city. However, as I have walked down Mt. Vernon and Aintree, I can easily count between 6-9 large canopy trees that have been removed. This is very disheartening. Now, I understand that sometimes trees have been damaged and it is necessary to take them down. However, I would strongly urge you to get multiple opinions if your trees are damaged and to what extent. Could you possibly just have the damaged part removed and

not the entire tree? Don't forget, tree companies make more money to take down an entire tree rather than just the damaged part. A second opinion never hurts and may actually save you money. Lastly, I implore you not to cut down your trees simply due to the fact that you don't want to have the hassle of leaves. That is an extremely short-sighted vision that doesn't take in to consideration the neighborhood at large. I know that most of our citizens feel the same way, and will maintain their existing trees and plant new ones. The gift of our neighbors' trees benefit all of us.

Remember, the City of St. Regis Park is a great place to live. Together, we will make it even better!

MAYOR'S REPORT:

Mayor Davis introduced Mr. John McIntyre, CPA of McIntyre and Wooldridge. Mr. McIntyre presented the 2017-2018 financial audit report to the council. Mr. Weis made a motion to approve the report as presented. The motion was seconded by Ms. Willett and it passed without dissent. The information required to be reported will be published in the February 2019 city newsletter.

FINANCIAL REPORT:

Mr. Charles J. Veeneman, the city accountant presented the Financial and Investment Report for December 2018. Ms. Ecker requested an additional \$20,000.00 be allocated to the tree board budget for the remaining 6 months of the fiscal year. The money will be used for tree maintenance, spring tree planting and arborist services. After an extended discussion, Mr. Amback made a motion to approve the \$20,000.00 increase for the current fiscal year. Mr. Fountain seconded the motion and it passed without dissent. The revised tree board budget for 2018-2019 will be \$45,000.00

Independent Auditor's Report

The Honorable Mayor and Council of the City of St. Regis Park, Kentucky

Report on the Financial Statements

We have audited the accompanying financial statements of the governmental activities and each major fund of the City of St. Regis Park, Kentucky as of and for the year ended June 30, 2018, and the related notes to the financial statements, which collectively comprise the City's basic financial statements as listed in the table of contents.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express opinions on these financial statements based on our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risk of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to

design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. Accordingly, we express no such opinion. An audit also includes evaluating the appropriateness of accounting policies and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinions.

Independent Auditor's Report (continued)

Opinions

In our opinion, the financial statements referred to above present fairly, in all material respects, the respective financial position of the governmental activities and each major fund of the City of St. Regis Park, Kentucky at June 30, 2018, and the respective changes in financial position for the year then ended in accordance with accounting principles generally accepted in the United States of America.

Other Matters

Required Supplementary Information

Accounting principles generally accepted in the United States of America require that the management's budgetary comparison information on page 19 be presented to supplement the basic financial statements. Such information, although not a part of the basic financial statements, is required by the Government Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We have applied certain limited procedures to the required supplementary information in accordance with auditing standards generally accepted in the United States of America, which consisted of inquiries of management about the methods of preparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

Management has omitted the Management's Discussion and Analysis that accounting principles generally accepted in the United States of America has required to be presented to supplement the basic financial statements. Such missing information, although not a part of the basic financial statements, is required by the Government Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. Our opinion on the basic financial statements is not affected by this missing information.

Other Reporting Required by Government Auditing Standards

In accordance with *Government Auditing Standards*, we have also issued our report dated, January 4, 2019, on our consideration of the City of St. Regis Park, Kentucky's internal control over financial reporting and on our test of its compliance with certain provisions of laws, regulations, contracts and grant agreements and other matters. The purpose of that report is to describe the scope of our testing of internal control over financial reporting and compliance and the result of that testing and not to provide an opinion on the internal control over financial reporting or on compliance. That report is an integral part of an audit performed in accordance with Government Auditing Standards in considering the City's internal control over financial reporting and compliance.



BRANCHING OUT

Since some of you have now had your city-planted trees for several years, we wanted to address a question you may have: When is it time to start trimming, limbing up, fertilizing, or otherwise maintaining my new tree?

Each tree will have its own needs, but here are several thoughts and some links to get you started:

- If you are having to duck to mow the grass, or if branches are blocking the sidewalk for walkers, you might want to limb up your tree. Don't cut too close to the trunk, but don't cut too far either. Cut right outside the "branch collar," the slightly swollen-looking area where the branch meets the trunk.
- 2) Never "top" a tree unless an arborist has told you it is necessary.
- 3) In ideal circumstances, trees get all the nutrients they need from the soil, but there may be times you want to fertilize. Fall to mid-Spring is actually the best time to fertilize, when the tree is focusing on its root system, rather than leaves, blossoms, etc. Spreading granular fertilizer might help your grass, but it is not necessarily going to get nutrients to the roots, where the tree can absorb them. A root feeder is a simple device with an easy learning curve. Your garden center or arborist can help you decide if your tree needs to be fertilized, and what kind of fertilizer it needs.
