

#### CITY OF ST. REGIS PARK ORDINANCE NO. 3, SERIES 2019-2020 SPEED HUMP INSTALLATION POLICY

WHEREAS, the use of Speed Humps to control speeding, on neighborhood streets, is documented within many jurisdictions, across the country.

AND WHEREAS, the Federal Highway Administration (FHWA) announced, in 1999, their plans to release a revised edition of the MUTCD. The FHWA announced that they were including a section on the proper signage and markings for jurisdictions choosing to install Speed Humps. The FHWA chose signage and marking standards based on researched conducted and published standards for construction, signage and markings of Speed Humps in their recommended practice entitled <u>Guidelines for the Design and Application of Speed Humps</u> and were adopted, by FHWA, for inclusion in the MUTCD.

NOW THEREFORE, based on the adoption of the ITE guidelines, by FHWA, the revised MUTCD now refers to Speed Humps. The City of St. Regis Park has interpreted this action to infer that the decision to use Speed Humps is a local decision and would not violate Kentucky Revised Statutes and therefore the City of St. Regis Park does hereby adopt the following policy:

#### **SECTION 1: DEFINITIONS**

The following definitions apply for the purposes of this policy:

APPLICATIONS for speed humps include a petition of affected residents and property owners, which shall be defined as both residents and property owners who live or own property on a low-density residential street, which has vehicular access to and is located within the same block (measured intersection to intersection), to any proposed speed hump;

FUNCTIONAL CLASSIFICATION- "The process by which streets and highways are grouped into classes or systems according to the character of service they are intended to provide." (Highway Functional Classification and Needs Study Manual)

- Arterial System- provides for through traffic movement between areas and across the city with limited access to abutting property.
- Collector System- provides for traffic movement between arterials and local streets, with limited access to abutting properties.
- Local System- provides direct access to abutting properties;

#### MUTCD - Manual on Uniform Traffic Control Devices

SPEED HUMPS are geometric design features of a roadway, consisting of a raised area in the roadway pavement surface, extending transversely across the travel

way, whose primary purpose is to reduce the speed of vehicles traveling along the roadway.

#### **SECTION 2: ELIGIBILITY REQUIREMENTS**

All of the following criteria must be satisfied for a street to be considered eligible for speed hump installation.

- 1. Petition. The process to request a speed hump begins with the submittal of petitions documenting written approval from 70% of the households within the same block, measured intersection to intersection, from the proposed hump. Each residential structure located between the two intersections where the speed hump is proposed shall count as one voting unit. The vote recorded for each residential unit shall be the majority of all those over the age of 18 who are either living at that residential unit and/or are the property owners. If 70% of the total number of residential structures as defined herein is not a whole number, it will be rounded up to the next whole number. If no petitions are received from a household, that household will be counted as a no vote. Only the City's official petition form may be used to vote.
- 2. <u>Location of the Street</u>. The land uses of the properties abutting the street where the speed hump is proposed must be composed of low-density residential dwellings.

#### 3. Operational Characteristics of the Street.

- a. The street must be used to provide access to abutting low density residential properties. The street must not be identified as a Collector or higher-level street, as defined by the Jefferson County Comprehensive Plan, Core Graphic.
- b. There must be no more than one moving lane of traffic in each direction.
- c. The street must have a speed limit of 25 mph as determined in accordance with the City of St. Regis Park Code of Ordinances.
- d. The street must not be so close to a Fire Department facility as to significantly interfere with emergency vehicle operations.

#### 4. Geometric Characteristics of the Street.

- a. The street must have adequate sight distances to safely accommodate the hump as determined, in writing, by the City, as defined in the <u>Traffic</u> Engineering Handbook.
- b. The street must not have curves or grades that prevent safe placement of the humps. Humps may be located on streets that contain curves and/or grades, but the hump itself shall not be located within a significant horizontal curve, or a vertical grade greater than eight (8%) percent.

c. The street must be paved. If there are no curbs, a special design of speed hump must be used to prevent vehicles from going around the speed hump.

#### SECTION 3: SPEED HUMP REMOVAL AND ALTERATION

The process for speed hump removal or alteration by citizens is the same as the process for installation.

#### **SECTION 4: SPEED HUMP LOCATION**

The exact speed hump location is subject to traffic safety and operations requirements and shall be as determined by the City of St. Regis Park's engineering consultant.

#### SECTION 5: DESIGN STANDARDS AND PROCEDURES

The installation and design of speed humps shall comply with the Institute of Transportation Engineers, Recommended Practice, <u>Guidelines for the Design and Application of Speed Humps.</u> All signage and pavement markings shall comply with the current edition of the MUTCD. Should signage and markings not be defined in the MUTCD, they shall comply with ITE's Recommended Practice, <u>Guidelines for the Design and Application of Speed Humps.</u>

Please note that these guidelines and the state and national laws that govern them require warnings for motorists that a speed hump is on the road. They require markings on the road showing the speed hump's location and/or street signs on posts that warn of an upcoming speed hump. The signs are an integral part of placing a speed hump on a roadway and the installation of a speed hump without these signs is illegal.

#### SECTION 6: PROCEDURES FOR SPEED HUMP INSTALLATION

1. The initial request for the installation of speed humps must originate from the residents and/or property owners on the street. As stated above owners and renters of property are each allowed to weigh in on the decision equally. The process to request a speed hump begins with the submittal of petitions documenting written approval from 70% of the households within the same block, measured intersection to intersection, from the proposed hump. Each residential structure located between the two intersections where the speed hump is proposed shall count as one voting unit. The vote recorded for each residential unit shall be the majority of all those over the age of 18 who are either living at that residential unit and/or are the property owners. If 70% of the total number of residential structures as defined herein is not a whole number, it will be rounded up to the next whole number. If no petitions are received from a household, that household will be counted as a no vote. Only the City's official petition form may be used to vote. A request in writing with such petition must be forwarded to the City address of:

- 2. After verification of the petition(s), the City may conduct transportation engineering studies, including but not limited to traffic volume, accident and speed studies, and solicit comments and recommendations of other agencies, including but not limited to emergency services. The City Council shall determine whether to install the humps, based on the all the studies, final design and the installation costs. The City will make determination of eligibility based on available data in a timely matter.
  - a. If the street is determined not to be eligible, the applicant's representative will be given written notification of that determination and its reasons. Any denial may be appealed in writing to the City Council within 15 days of the notification date.
  - b. If the application for the speed hump installation is determined to be eligible for consideration, a meeting will be arranged between the applicant's representative and the appropriate City Staff to discuss the installation. The final design including specific location of the speed humps and the signs required for the humps will be approved at the next regularly scheduled city meeting. All the residents on the petitions submitted will be noticed with the date, location and time of the meeting so that they can attend.

#### SECTION 7: EFFECTIVE DATE.


