## Tree Planting Request

As a resident of St. Regis Park, I agree to give the City of St. Regis Park (and its agents) my permission to enter my premises for the purpose of planting trees and release them from liability for same and further agree that any and all future maintenance of any planted tree or trees is my responsibility. I agree to maintain my new tree(s) to the best of my ability using the guidelines provided by the city arborist. [Summary: I will ensure that my tree(s) receive a regular thorough soaking of the soil in the root zone, and that the soil is kept consistently moist (but not wet) until the tree is well established. I will ensure that my tree(s) maintain a healthy 2-3 inch layer of mulch, with a two-three inch non-mulched space around the trunk.]

***(A) No person who is the owner of any animal shall permit it to run at large in any public road, highway, street, lane or alley, or upon an enclosure without the consent of the owner of the yard, lot or enclosure.***

**"AT LARGE"** referenced above is defined as off the premises of the owner, and not under the control of the owner or his agent either by leash, cord or chain.
