New residents will be pleased to know that your large "cover" trees are free. That's right, FREE! Simply let the Tree Board know the variety you prefer and where you want it planted and they'll get you on the spring planting list. If you aren't sure, our City Arborist, Cindi Sullivan will be glad to assist with your selection.

This fall's planting will begin in mid-December and will include about 25 new specimens, bringing the total to over 300 in the last 6 years. We are proud of our effort to "Re-Tree the Park" and would like to express our gratitude to the Tree Board for the all the volunteer work that they do to make it happen. Following are the Minutes of the November 2020 City Council Meeting for the City of St. Regis Park, held at 7:00 p.m., Tuesday, November 3, 2020 via ZOOM video conferencing.

Council Members: John Amback, Donald Fountain, Craig Theis, Eric Shackelford, Louie Schweickhardt, and Cheryl Willett.

### Absent: Jeff Weis

Mr. Charles Venneman, CPA presented the October 2020 financial report. Mr. Shackelford made a motion

to approve the October 2020 financials. Ms. Willett seconded the motion and it passed without dissent.

Mr. Shackelford made a motion to approve the October 2020 Minutes. Mr. Amback seconded the motion and it passed without dissent.

Mr. Schweickhardt made a motion to approve a variance for the construction of a covered auxiliary structure behind the house at 4403 Dannywood Road. Mr. Amback seconded the motion and it passed without dissent.

What does November mean for your trees? If you have a Gator Bag on a new tree, you should take it off around Thanksgiving and store it until about St. Patrick's Day. For the most part in the winter, trees are fine, but should we have an unseasonably warm late Fall, you might want to water once a week. If your new tree has had the bag on it for two years, and the bag is still good, we would appreciate your returning it, cleaned off, if possible, to the front porch of 4512 Lincoln Road, so we can re-use it.

This year's new trees will be planted in mid-December. If you missed the cutoff date, please get your name on the Spring list by contacting Susan Messerschmidt at <u>smesserschmidt4313@gmail.com</u> Nothing makes us more thankful than having you request a free tree!

(E) A fence constructed on property lines must be made of ornamental metal, wire or wood and shall not be over six feet in height from ground level. Solid or closed construction type fences are not permitted.
