Upper Highlands Swim Club Update

The Upper Highlands Swim Club has been a long-standing family friendly gathering spot for cooling off and social events for generations. For the benefit of the Brookhaven and St. Regis Park neighborhoods, a group of residents came together years ago to form an ongoing Pool Board with strong leadership positions. The current Board has put in countless hours of volunteer time, energy, and even personal funds for operations and maintenance of the pool and property. Private parties, sand volleyball leagues, cornhole tournaments, and cookout potluck events draw friends together at our neighborhood pool. The Board members, who have been in place and running every aspect of the swim club for over a decade, are ready to "Pass the Baton" while working with a new volunteer Board and Committees to open the pool for the 2022 Summer Season.

The Covid pandemic of 2020 (and now 2021) derailed the possibility of offering memberships. Louisville Metro Health restrictions simply did not lift in time for us to gather a dedicated volunteer base, supplies, and staffing. As a result, we were unable to open and operate throughout the last two summers.

Through the Finance Committee's guidance, we want our neighborhood Upper Highlands Swim Club to reopen and operate in a fiscally responsible and sustainable way. We intend to have the funds, employees, and volunteer manpower to maintain and make needed repairs and updates to both the pool and property. It truly "takes a village" as they say, and we hope to count on the "village" of the Brookhaven and St. Regis Park neighborhoods to re-imagine the possibilities of drawing community together at the swim club. Our goals are to grow a large and active membership base, build on our roster of dedicated volunteers, and fill Board Member and Committee Leadership roles. We are moving forward and planning a "new" Upper Highlands Swim Club for the Summer of 2022 and beyond!

A *Pig Roast Dinner*, raffles, music, and other Upper Highlands Swim Club fundraising events were held at the Ascension gym on Saturday, August 21st. The supporters who attended, ate great food, socialized, and placed raffle bids. Thank you to all the volunteers and many generous donors of the wonderful raffle items and baskets that helped make this such a success! Special thanks to Ascension Parish for graciously offering the use of their facilities and much more.

The next fundraiser we hope you will attend is the Food Network & Guinness Book of World Record-Holding "Chris Cakes of Indiana All You Can Eat Pancake and Sausage Breakfast". It will occur on Sunday September 12th, in the Ascension Cafeteria from 10 AM until 12 PM (or until the last customer in line is served). If you are unfamiliar with Chris Cakes, look up their very entertaining airborne-style pancake service on YouTube. This event will be fun for the entire family! The cost is \$8 per person, cash or "Venmo Pay". Children aged 2 and under eat free. Carryout will be available by taking one-trip through the to-go box line at the same price.

IF YOU ARE PARTICIPATING

| Try to set up in your driveway or yard close to the street to be more visible. |

| Please park your personal vehicle further up in your driveway so that you do not take space on the street in front of your house and thus help keep the area on the street in front of your home open for traffic and allow parking for buyers coming from outside the City. Any suspicious behavior should be reported immediately. |
| People come early, so plan to set up as early as possible. |
| Extra police will patrol that day. For any problem, contact them immediately and try to get the license plate number and a car description of an offender's vehicle. |
| Join with neighbors and hold a multi-house sale at one location for a larger sale. |
| IF YOU ARE NOT PARTICIPATING |
| Please park your vehicle(s) off the street, but close to the street to avoid your driveway being used as a turn around point. |
| Report any suspicious or unusual activity to the police patrolling the City during the yard sale. |
| If possible, keep your garage door closed during the hours of the yard sale so that it will not attract attention. |

There will be *NO PARKING* on the sides of the streets where fire hydrants are located. "No Parking" signs will be posted on the previous Thursday evening. Police patrols will ticket those vehicles who do not comply.

Branching Out, September, 2021


It's Back to School time, and this former teacher is standing in front of the classroom, ready to provide her classroom rules! I have to admit this year's rules might be influenced a bit by the drought we find ourselves in, as I write this. Sit up straight, boys and girls, here goes!

- 1. It is very hot and dry. If you have brand new trees, you should be watering them at least three times a week until rains come, and the heat moderates.
- 2. Your city-planted trees are all less than seven years old. All need weekly water during extended dry times.
- 3. Heck, even your well-established trees need a drink when we go this long without rain.
- 4. Don't forget your commitment to mulch city-owned trees. On my bike rides, I see many trees with little or no mulch. Your teacher does not approve.
- 5. Please try everything you can to save large canopy trees. They add value to your home, reduce your air conditioning costs, cool your yard for outdoor activities, provide shade for those walking on the sidewalk, and provide the environmental benefits that we all know. We realize that diseased or dangerous trees need to be removed, but check your options out with two reliable arborists before you remove.
- 6. Fall is the best time to plant a tree. Consider adding trees this year. Send your request form to Susan Messerschmidt, smesserschmidt4313@gmail.com
- 7. Between now and leaves dropping, you can have the health of your trees evaluated, if you have any concerns. Tree services are very busy right now, so prepare for a wait. If you follow the city's procedures, you may be able to receive reimbursement for work done to save or improve a tree. Contact Joe Hinkle, joerunjoe@gmail.com
- 8. Enjoy your outdoor classroom! Make it a good year for your trees!
