Dear Citizens,

I hope this newsletter finds all of you having a safe and healthy 2022! Our next council meeting will be at the Jeffersontown Fire House on Taylorsville Rd. at 7 p.m. on February 1, 2022.

I would like to thank Councilwoman Cheryl Willet and her son Matt, as well as Councilman Louie Schweickhardt and Councilman Matt Sanderfer for all of their hard work that they put in to the Holiday Party this year. Please remember that the city council has decided to change off-duty police firms effective 2/1/22. The new group will provide the same amount of hours as the previous group. The hours will be spread out and staggered accordingly so there is no pattern. The new group is being tasked with issuing tickets to ALL people who don't abide by the speed limit or stop signs. This includes residents and non-residents alike.

We received notification that the federal money we received has less restrictions now on how it has to be used. The city accountant, Mr. Charles Veeneman, CPA presented the December 2021 financial report. Ms. Willett made a motion to approve the report. Mr. Weis seconded the motion and it passed without dissent.

Mr. Shackelford made a motion to approve Municipal Order #4, 2021-2022, an order relating to the use of the American Rescue Plan Act (ARPA) funds to provide funding to businesses and organizations struggling because of the COVID 19 health emergency. Mr. Weis seconded the motion and it passed without dissent.

Mr. Amback made a motion to approve the December 2021 meeting minutes. Mr. Theis seconded the motion and it passed without dissent.

Did You Know?

REMOVING AND DISCARDING ANIMAL WASTES

- (A) It shall be unlawful for any owner or person in charge of a dog, cat or any other animal to permit the animal to be on public property, or any private property other than that of the owner or person in charge or control of the animal without the permission of the owner of the property, or on any streets, sidewalks or rights-of-way in the city, without the owner or person in charge of the animals to have in his or her possession, a suitable device for the picking up, collection and proper sanitary disposal of the animal feces or manure.
- (B) It shall be unlawful for the owner or person in charge of a dog, cat or any other animal to permit or allow the animal to excrete manure or feces on public property, or on any private property other than that of the owner or person in charge or control of the animal without the permission of the owner of the property, or on any streets, sidewalks or rights-of-way in the city, unless the owner or person in control of the animal immediately removes all feces deposited by the animal and disposes of same in a sanitary manner.



Are you planning a Construction Project at your home in St. Regis Park?

The City of St. Regis Park requires homeowners apply for a Letter of Compliance from the City to ensure that their planned project complies with Ordinance Chapter 150, Building Regulations before they start. The following exterior projects require an application to St. Regis Park:

- Fences
- Porches
- Decks (both new and replacements)
- Driveways
- Carports
- Garages
- Outdoor Temporary Storage Units (PODS)
- Pools (over 400 gallons)
- Utility Sheds
- > Playhouses
- Auxiliary Structures
- Building additions (nearly any structure attached to the house)
- Houses

Don't Forget

In addition, homeowners must obtain all building, electrical, plumbing, and any other permits from Metro Louisville for construction projects as required by Louisville/Jefferson County. St. Regis Park will check Louisville Metro Building permits to ensure that buildings, electric and plumbing are up to code and inspected. Many projects require an approval both from the City of St. Regis Park and Louisville Metro.







BRANCHING OUT

Procedure for Requesting Reimbursement for Tree Maintenance

- 1. Using the Maintenance Form from our website, retreethepark.com or from the St. Regis Park newsletter, contact Tree Board member Joe Hinkle by email, joerunjoe@gmail.com, requesting to participate in the maintenance program. If you do not have a form, email Joe, and he will send you one. Please include on your form a description of the problem causing concern and location of the tree on the property.
- 2. Proceed to get evaluations and estimates from at least two tree services that ARE BONDED, INSURED, AND HAVE A LICENSED ARBORIST ON STAFF. Please ask to have the arborist sign the estimate. We have a recommended list below, but others may qualify. If the recommendations are similar, email your two estimates to Joe. If they are not—e.g., one service recommends trimming, the other removal, still email both (or all) estimates to Joe, and he will notify our consulting arborist, who will be the tiebreaker. Her recommendation will determine whether you are eligible for reimbursement of 40% up to \$500 per year. In other words, for example, if Cindi feels a tree can be saved, but you opt for removal, you would likely not qualify for reimbursement.
- 3. Upon receipt of your estimates, Joe will email you approval to contract with one of your qualified tree services. Be sure to save all of your paperwork.
- 4. When work is completed, send a copy of the signed estimate/invoice to city arborist (cindihsullivan@gmail.com) and she will inspect the work. She will then email you that the reimbursement is approved, copying the city treasurer and Joe. At this point you may apply for reimbursement, submitting a copy of the invoice to City Treasurer at stregispark@gmail.com, or sending a hard copy to City of St. Regis Park, PO Box 20429, Louisville, KY 40250-0429.




