I would like to start this newsletter by hoping everyone is having a safe and happy summer. The neighborhood looks great with all of your landscapes in full bloom and the trees planted in recent years are maturing to the point they can be used for shade in these hotter months. Thanks again for your hard work and dedication to improving our neighborhood. Also, many of you may have noticed the new LED streetlights have been installed on our existing poles. I think they do a good job providing sufficient light but if you feel an area of the city has a dark spot, we can ask LG&E to add a pole where possible.

At the June council meeting the council members voted unanimously to approve our fiscal budget for 2023/24 and approved changes to our driveway ordinance. Please contact the city for a letter of compliance if you are planning to start any exterior improvement projects in the near future.

Some residents attended June's meeting to voice concern over yard debris and other items piling up behind their neighbor's garages. Please be cognizant of the fact others will have to look at this. You can dispose of all your unwanted items on Tuesday trash days. Our sanitation contract allows you to throw away anything that will fit in either your chosen trash receptacle or the big brown cans Rumpke provides. They will also pick up bundled yard waste and other bundled trash or easy to pick up items like rolled carpet. The only stipulation is the bundles must be in manageable sizes approx. 4ft or less. Should you have larger items such as couches or other furniture you can call Rumpke at (800) 828-8171 to schedule a pick-up.

We recently heard reports of car break ins in the 4300 blocks of Lincoln and St Regis. We have alerted our police provider to this situation, and they will try to assign patrols for later hours on the weekends when they have personnel available. However, this will only help as the officers cannot be everywhere all the time. The police have advised the most effective way to prevent this type of criminal activity is:

- 1) Lock your car doors, garages, and homes.
- Do not leave valuables in plain sight inside locked cars

Finally, I'd like to remind everyone that we will host the "St. Regis Park City Wide Yard Sale" again this year on Saturday September 9th from 8:00 AM to ???????. This is an excellent opportunity to make a few bucks selling your unwanted items. Our yard sales have a heavy attendance every year.

Ms. Lewis made a motion to approve the May 2023 financials. The motion was seconded by Mr. Weis, and it passed without dissent.

Ms. Willett made a motion to approve the 2nd reading of Ordinance 2, 2023-2024, an ordinance establishing the budget for FY23-24. The motion was seconded by Mr. Weis, and it passed without dissent via a roll call vote.

Mr. Weis made a motion to approve the 2nd reading of Ordinance 6, 2022-2023, an ordinance amending the driveway construction ordinance. The motion was seconded by Ms. Lewis, and it passed without dissent via a roll call vote.

Mr. Sanderfer made a motion to approve Municipal Order 1, 2023-2024. This order will allow the use of ARP A funding for the Lincoln Road/Oxmoor drainage project. Mr. Sanderfer seconded the motion, and it passed without dissent.

Mr. Shackelford made a motion to adjourn the meeting. The motion was seconded by Mr. Amback, and it passed without dissent. The meeting adjourned at 8: 12 pm

CITY OF ST. REGIS PARK ORDINANCE NO. 6, SERIES 2022-2023 AN ORDINANCE AMENDING ORDINANCE SECTION 150.18 RELATING TO DRIVEWAY CONSTRUCTION

WHEREAS, The City of St. Regis Park Council finds that extending driveways into the front yard past the side wall of the principal structure on the lot encourages vehicular parking in front of houses,

WHEREAS, the City of St. Regis Park Council finds that front yard vehicular parking diminishes the aesthetics of the neighborhood and diminishes property values,

NOW THEREFORE, be it ordained by the City of St. Regis Park,

SECTION 1:

The City of St. Regis Park does hereby amend ordinance Section 150.18 as follows: § 150.18 GARAGES, CARPORTS AND DRIVEWAYS.

- (A) All garages shall be no more than 28 feet wide and 26 feet deep. Garages shall have a roof pitch no greater than a 5/12 pitch and no detached garage may be over 16 feet in height, as measured from the peak of the roof straight down to ground level. No attached garage shall be higher than the principal structure. Garages can be either frame, brick or stone, no concrete block garages are allowed. The exterior may be faced with brick or stone, however, wood, aluminum or vinyl siding may be used on all other sides. Garages may be attached, detached or semi-attached (by roofed breeze way) to the residence. If detached, semi-detached, or attached from the house the garage must be erected in accordance with Jefferson County Planning Commission Regulations.
- (B) Carports shall be of frame, brick, stone, ornamental metal or a combination of same. No flexible materials, such as canvas, cloth or plastic can be used as a roofing material on the carport. Commercially available pre-fab metal carports are not allowed, unless they have been designed to match the quality of construction and material of the surrounding residential structures. A carport shall not exceed ten feet in width and may be attached to a house or a garage. The side wall away from the house or garage shall not exceed three feet in height. If there is an end wall, it shall not exceed three feet in height. The carport type, design and placement on the lot must be approved by the city in advance of its placement or construction to ensure that its design, construction, materials and placement on the lot is in keeping with the surrounding residential structures. Only one carport structure is allowed on each lot.
- (C) All driveways or parking lots shall be asphalt, concrete, or other hard durable surface approved by the city (no gravel). Construction shall be completed at the time of building the first structure on the lot. Driveways shall be kept in good repair and free of significant deterioration. Any additions or enlargements to any driveway or parking area in the city shall require a permit from the City of St. Regis Park. Anyone proposing to add or enlarge their driveway or other parking area must submit plans showing the location of the

enlargement or addition on the lot In addition, the type of construction, driveway material type and total dimensions must be part of the application for a permit. The city will make its decision to either grant or deny the permit, based on the following factors:

- (1) Whether the driveway or parking area is compliant with the applicable sections of the land development code and is no wider than the allowed 20 feet in width and does not extend past a line extending from the front side exterior wall of the lot's principal structure, nearest to the edge of the driveway, which line is perpendicular to the road right of way:
- (2) Whether the addition or extension serves as a legitimate vehicular access to a residence or a garage, or a parking area for a boat or recreational vehicle located ten feet behind the rear wall of the residence and in compliance with the city's parking ordinances;
 - (3) Whether the applicant has properly dealt with drainage for the project;
 - (4) Whether sidewalks are impacted by the addition or extension; and
- (5) Turn-arounds, pull-offs, circular, oval, or other non-standard driveways in the front, side or street side yard are not allowed in any part of the city, other than those homes whose driveways exit onto the heavily traveled roadways of Browns Lane and Lowe Road. This prohibition does not apply to driveways or parking areas that were constructed prior to the effective date of this section.

SECTION 2:

This ordinance shall take effect upon enactment and publication according to law.

CITY OF ST. REGIS PARK ORDINANCE NO 1, SERIES 2023-2024 AN ORDINANCE PROVIDING FOR THE ASSESSMENT OF AN AD VALOREM TAX AND A SANITATION FEE

WHEREAS, in order to provide revenue for general governmental purposes and operation, with manner of assessment and collection of said taxes, and

WHEREAS, to provide the assessment of all real property within the City corporate limits as of January 1, 2023, and

WHEREAS, the provisions for the levy and collection of these taxes shall apply for a period starting on July 1, 2023, and ending June 30th, 2024.

NOW THEREFORE, the council of the City of St. Regis Park does ordain as follows:

Section 1:

The assessment of said real property shall be the valuation as listed on the Jefferson County Property Valuation tax records as of January 1st, 2023, and is hereby adopted as the assessment for ad valorem tax purposes.

Section 2:

To levy an ad valorem tax of all real property and real property of utility companies as allowed by law at the rate of \$.095 cents per one hundred dollars of the assessed value.

Section 3:

To levy a special sanitation fee assessment under KRS 82.095 on every residence within the city at the rate of \$335.45 per household.

Section 4:

Said taxes shall be due and payable to the "City of St. Regis Park" and mailed to the City of St. Regis Park, C/O Veeneman CPA, 2527 Nelson Miller Parkway, Suite 205, Louisville, KY 40223-3165, as follows: July 15 through September 30th the discounted amount (5% discount off face amount). Face amount to October 31st. November 1 and thereafter, face amount of total bill, plus fifteen percent (15%) penalty, plus an additional one percent (1%) interest charge compounded per month starting November 1, 2023. On November 1, 2023 the tax bill becomes delinquent and collection of said taxes shall be made in the manner prescribed by law. Failure to pay the tax and penalty shall and will constitute a lien upon the property in question.

Section 5:

The revenue from said taxes, interest and penalties shall be used for the general operating expenses of the City and for the general purposes for the City in the discharge of its municipal functions as ordained, resolved or directed by the City Council of St. Regis Park. Any surplus from said taxes shall go to the general operation fund of the City.

I agree to maintain my new tree(s) to the best of my ability using the guidelines provided by the city arborist.

I will ensure that my tree(s) receive a regular thorough soaking of the soil in the root zone, and that the soil is kept consistently moist (but not wet) until the tree is well established.

I will ensure that my tree(s) maintain a healthy 2-3 inch layer of mulch over the root zone and that the mulch is kept from touching the trunk.

IF YOU ARE PARTICIPATING

Try to set up in your driveway or yard close to the street to be more visible.
Please park your personal vehicle further up in your driveway so that you do not take space on the street in front of your house and thus help keep the area on the street in front of your home open for traffic and allow parking for buyers coming from outside the City. Any suspicious behavior should be reported immediately.
People come early, so plan to set up as early as possible.
Extra police will patrol that day. For any problem, contact them immediately and try to get the license plate number and a car description of an offender's vehicle.
Join with neighbors and hold a multi-house sale at one location for a larger sale.
IF YOU ARE NOT PARTICIPATING
Please park your vehicle(s) off the street, but close to the street to avoid your driveway being used as a turn around point.
Report any suspicious or unusual activity to the police patrolling the City during the yard sale.
If possible, keep your garage door closed during the hours of the yard sale so that it will not attract attention.

There will be *NO PARKING* on the sides of the streets where fire hydrants are located. "No Parking" signs will be posted on the previous Thursday evening. Police patrols will ticket those vehicles who do not comply.


