I hope this letter finds everyone staying warm with no frozen pipes amid the brutal cold snap that came through mid-January. The 2-3" snow accumulation we experienced followed by the near zero temperatures forced us to pre-treat and post-treat all of the streets to keep them clear. Many thanks to those of you who normally park on the street for moving your cars to the driveway so our plow and salting company could do their job. For those of you new to the neighborhood, we respectfully request your assistance in keeping the streets clear when a snow or ice event is in the forecast. This will prevent large snow piles around your vehicle when deeper snow events occur and allow piling on the gutter side of the street instead of near the middle.

There is not much to report from the January meeting. As I mentioned in previous newsletters, we are gearing up for spring paving and drainage projects, so stay tuned for more specifics.

Finally, many residences did not have trash and recycling at the street on Monday night 1/15. This was the Martin Luther King holiday so presumably you thought trash was delayed a day such as we experience on Memorial Day, Labor Day and most recently Christmas and New Years Day. Did You Know?

50.01 PLACEMENT - COLLECTION AND REMOVAL

(A) No garbage, grass or trash shall be placed at the curb side before 3:00 p.m., the day prior to pick up.

(B) All garbage cans and items not collected shall be removed from the curb side by 7:00 p.m., the day of pickup.

(C) During the fall of the year, leaves may be placed at the curbside the day prior to pick up after 3:00 p.m., as provided in division (A).

Trash Pick-up Day

St. Regis Park's normal collection day is Tuesday. When a holiday such as New Year's Day, Memorial Day, Independence Day, Labor Day, or Christmas Day falls on Monday or Tuesday, then collection will be on Wednesday of that week.

St. Regis Park Tree Maintenance Program

Reimbursement of 40% up to \$500 per fiscal year (7/1/ - 6/30)

1. Complete the Maintenance Form. Email to Joe Hinkle, joerunjoe@gmail.com, or mail to 2605 Hurdle Way
2. Proceed to get evaluations and estimates from at least two qualified tree services. Qualified tree services **must** meet these 3 requirements:

1. ARE BONDED 2. INSURED 3. LICENSED ARBORIST ON STAFF

(We are familiar with the services listed at the bottom of the page, but you are free to work with any service that meets the qualifications outlined by the St. Regis Park city council)

3. Send a copy of your estimates to Joe. If the estimates are similar in recommended work, he will tell you to proceed with the vendor of your choice. If there is a major discrepancy (such as one calls for removal while the other calls for minor work) Joe will have our city arborist review the request.
4. When work is completed, send a copy of the paid invoice to Joe (joerunjoe@gmail.com) and he will approve the reimbursement. At this point, a copy of the paid invoice will be submitted to the City Treasurer for reimbursement.

Tree Maintenance Request Form

As a resident of St. Regis Park, I agree to give the City of St. Regis Park (and its agents) permission to enter my premises for the purpose of evaluating the condition of my tree(s) and release them from liability for same.

I understand that licensed arborists and/or our city arborist will approve what work should be done so that I can become eligible for the city's tree maintenance reimbursement program. Sign below and submit by scan or digital photo to joerunjoe@gmail.com or mail to St. Regis Tree Board PO Box 20429, Louisville KY 40250-0429. Briefly describe what you think needs to be done - limb up oak in front yard, evaluate maple in back yard, etc.
